



THIS CONTRACT for the personal services of FREEWORLD made this _____ DAY OF _____, by and between FREEWORLD (hereinafter referred to as "ARTIST") and _____, (hereinafter referred to as "EMPLOYER").

IT IS MUTUALLY AGREED BETWEEN THE PARTIES AS FOLLOWS:

Employer hereby engages the Artist and the Artist agrees to furnish the entertainment presentation hereinafter described, upon the terms and conditions set forth:

All payments will be paid as follows:

- (a) A deposit of \$ _____ shall be paid by employer to and in the name of FREEWORLD no later than _____
- (b) The balance of guarantee of \$ _____ shall be paid to Artist or Artist's designated representative during the first intermission on the night of engagement by cash or cashier's check only.
- (c) Additional payments, if any, shall be paid by Employer to Artist on or before conclusion of engagement.

TERMS: Artist's obligations are subject to detention or prevention by sickness, inability to perform, accident, means of transportation, Acts of God, riots, strikes, labor difficulties, epidemics, any act of any public authority or any other cause, similar or dissimilar, beyond Artist's control. Employer agrees that Artist may cancel engagement hereunder by giving Employer written notice thereof, at least thirty (30) days prior to the commencement date. In such case, there shall be no claim for damages by either party to this Contract, and the deposit will be refunded to the Employer in full. Employer shall be liable for any and all damages to Artist's instruments and equipment caused by Employer, his guests or members of his organization, business, invitees, employees, or structural faultiness of the place of engagement. Employer, in signing this contract himself, or in causing the same to be signed by a representative, acknowledges his authority to do so, and hereby assumes full responsibility and liability for the amount (Full Price Agreed Upon) stated herein, plus any fees and costs incurred in collecting the full price agreed upon.

This instrument and attached "Rider" contain the full agreement between the parties and no statement, promises, or inducements made by any party hereto or agent or representative of either party hereto, which is not contained in this written Contract shall be valid or binding and this Contract shall not be enlarged, modified, or altered except in writing signed by the parties and endorsed hereon.

THIS CONTRACT SHALL NOT BE BINDING UNLESS SIGNED BY ALL PARTIES. IN WITNESS WHEREOF, the parties hereto have hereunto set their names and seals on the day and year first above written.

FREeworld CONTRACT RIDER

THIS RIDER IS MADE PART OF THE PERFORMANCE CONTRACT IN ORDER TO INSURE THAT FREeworld IS ABLE TO PROVIDE YOUR ORGANIZATION WITH THE BEST QUALITY PERFORMANCE. WE ASK THAT YOU READ THE FOLLOWING REQUIREMENTS AND RETURN THIS RIDER WITH THE CONTRACT SO THAT THE BAND CAN PREPARE FOR YOUR EVENT.

- (A) FREeworld REQUIRES ACCESS TO A POWER SUPPLY OF THREE TO FOUR 30 AMP LINES OF 110 VOLT AC WITHIN 50' OF THE STAGE.
- (B) FREeworld REQUIRES SOME TYPE OF PRIVATE DRESSING ROOM THAT CAN BE LOCKED AND CAN ACCOMODATE AT LEAST EIGHT PERSONS.
- (C) THE BAND SHOULD HAVE ACCESS TO THE BUILDING AT LEAST FOUR HOURS PRIOR TO THE PERFORMANCE. IF THE BUILDING IS NOT OPEN, PLEASE INCLUDE THE TELEPHONE NUMBER OF SOMEONE WITH THE AUTHORITY TO OPEN THE BUILDING: _____
- (D) FREeworld REQUESTS THE FOLLOWING REFRESHMENTS TO BE PROVIDED AT THE EMPLOYER'S EXPENSE:
 - Two bottles of Gatorade (any flavor)
 - Three six packs of either a premium beer or assorted Coca Cola products.
 - At least two pitchers of fresh ice water and cups to be placed on stage immediately before the performance.
- (E) IN THE EVENT THAT FREeworld'S COMPENSATION INCLUDES OR CONSISTS OF A PERCENTAGE OF RECEIPTS FROM THE DOOR, THEN EMPLOYER AGREES THAT FREeworld HAS THE RIGHT TO HAVE A REPRESENTATIVE EITHER TAKE THE DOOR OR BE IN THE BOX OFFICE TO CHECK AND CONFIRM GROSS RECEIPTS. IF THE EMPLOYER TAKES THE DOOR, THEN THE EMPLOYER WILL FURNISH A COPY OF THE STATEMENT OF GROSS RECEIPTS.
- (F) NO PORTION OF THE ENGAGEMENT SHALL BE RECORDED ON FILM OR TAPE, REPRODUCED BY SIGHT OR SOUND DEVICES, OR TRANSMITTED FROM THE PLACE OF PERFORMANCE WITHOUT THE EXPRESSED WRITTEN CONSENT OF FREeworld'S MANAGEMENT.
- (G) EMPLOYER WILL PROVIDE AT EMPLOYER'S EXPENSE A STAGE RISING TWO FEET FROM THE FLOOR WITH MINMUM DIMENSIONS OF 15' DEEP BY 20' WIDE.
- (H) PLEASE INCLUDE A MAP OF THE BEST WAY TO GET TO THE EVENT SITE (VERY IMPORTANT!!)
- (I) EMPLOYER WILL AT ALL TIMES BE RESPONSIBLE FOR GUESTS AT THE ENGAGEMENT. THIS WILL INCLUDE MAKING SURE THAT NO ONE IS TO BE ON THE STAGE FROM THE TIME FREeworld BEGINS LOADING IN EQUIPMENT UNTIL THE TIME AFTER THE ENGAGEMENT THAT THE BAND'S EQUIPMENT HAS BEEN FULLY LOADED OUT. THIS PRECLUDES PERSONS THAT THE BAND MEMBERS SPECIFICALLY INVITE ON STAGE.
- (J) IN THE EVENT THAT THE ENGAGEMENT IS TO BE HELD OUTSIDE, EMPLOYER AGREES THAT THERE WILL BE AN ALTERNATIVE INDOOR SITE AVAILABLE IN CASE OF INCLEMENT WEATHER. FREeworld WILL NOT PERFORM IF THERE IS A CHANCE OF RAIN OR IF THE TEMPERATURE FALLS BELOW 55 DEGREES FAHRENHEIT. IN SUCH CASE THAT EMPLOYER DOES NOT HAVE AN ALTERNATIVE INDOOR ENGAGEMENT SITE AVAILABLE PRIOR TO THE BAND SETTING UP AND IT DOES RAIN, THEN EMPLOYER WILL BE LIABLE FOR THE FULL PRICE AGREED UPON AND FREeworld WILL NOT BE REQUIRED TO PERFORM.
- (K) EMPLOYER AGREES THAT NO TICKETS OR ADMISSION WILL BE CHARGED FOR THE ENGAGEMENT WITHOUT THE EXPRESSED WRITTEN PERMISSION OF FREeworld'S MANAGEMENT (UNLESS SPECIFICALLY CONTAINED IN THIS CONTRACT.)
- (L) EMPLOYER AGREES THAT FREeworld MAY SELL MERCHANDISE DURING THE EVENT WITH NO COMPENSATION TO EMPLOYER.
- (M) EMPLOYER WILL BE LIABLE FOR ANY AND ALL DAMAGES TO FREeworld'S INSTRUMENTS AND EQUIPMENT CAUSED BY EMPLOYER, HIS GUESTS, MEMBERS OF HIS ORGANIZATION, BUSINESS INVITEES, EMPLOYEES, OR STRUCTURAL FAULTINESS OF THE PLACE OF ENGAGEMENT.
